

IV NATIONAL CONGRESS OF SPORTS LAW

Last 13th and 14th of May there took place in Huesca the IV National Congress of Sports Law, organized by the Spanish Association of Sports Law and the signatures Tebas Coiduras Estudio Legal y Tributario and Law Sport, supported by the Foundation Alcoraz and by the Top Advice of Sports.

In this Congress there took part Mariano Carrasco, the technical National director and Recruitment Committee Chairman in the Nanbudo's World Federation, invited directly by the office Tebas Coiduras.

During both days celebrated in Huesca, there were debated the different aspects of the Law of the Sport, which has foreseen to be modified soon.

The referees were numerous and of very much weight in the sport of our country, as Javier Tebas, Vice-president of the League of Spanish Football and The Director of Tebas Coiduras, Ramon Barba Sanchez, General Assistant director of the Top Advice of sports, Manuel Cardenal Carro, Professor of Labour law of the University of Extremadura, Carlos del Campo, Secretary of the League of Football or the lawyer Juan de Dios Crespo.

In the first day, developed on May 13, there was exposed the current situation of the professional sport and the need to reform his juridical regime, not checked from the year 1990. Also there developed the model of the Sports Competitions at present, in a magisterial presentation at the expense of the Legal adviser of The National League of Professional Football, Miguel M^a García Caba, and to contribute ideas and to understand the need of the above mentioned reform concluded the session with a round table composed between others for the own Javier Tebas. In the same hotel of the Congress there was celebrated the dinner of show, to which there came D. Álvaro Burrell, General manager of Sports in Aragón.

The second and last day, Friday, the 14th of May, began with a conference on the tax system of the professional sport, which was chargeable to Jose Luis Carretero, Teacher of Financial law of the University of Malaga. Also they treated, in later presentations, the fraud in the professional sport and the figure of the Sports Joint-stock company, which generates so many doubts to the specialists. He concluded the morning with an exhibition of the Juridical Regime of the Audio-visual Laws. For the lunch, all the assistants moved up to the museum of Huesca, where they were offered a Spanish wine.

In the evening treated the labor relations in the professional sport and the sports bets on Internet. The Congress was closed by the comparative one between the past and the future of the regime of the professional sport, directed by D. Jose Bermejo Vera, Professor of the University of Saragossa. He took advantage of the Congress to celebrate, on having finished this one, the National Assembly of the Spanish Association of Sports Law.

The fact of the celebration of the Congress in Huesca opens borders for this city, trying to decentralize of the capital of Spain this type of events, which regularly are realized and which it is difficult that they go out of Madrid. Has been a strong bet and of great success, due to the massive participation of jurists and professionals related to the sport.

Mariano Carrasco stood out to feel proud to be able to take part in this type of professional events and indicated the interesting of the Congress, for the exposed thing and the extracted conclusions, beside showing his total agreement before the need to reform the Law of the
